## PERSONAL ACCOUNT FEE SCHEDULE

The Fee Schedule is part of your Account Agreement. Refer to the **Account Disclosures and Rules & Regulations** for interest rate and annual percentage yield information.

When you meet the minimum combined monthly average balance requirement, you may open additional Premium Plus Relationship, Premium Relationship, or Access Checking accounts with an equal or lower minimum balance requirement free of monthly maintenance fees. Access Checking always requires eStatement delivery to avoid maintenance fees.
